### INITIAL

\_\_\_\_\_ I understand that all board must be paid monthly and in advance. I hereby grant a lien to stable-owner for all unpaid charges. Lien activates on the 20<sup>th</sup> day of the month board is late.

\_\_\_\_\_ This horse, to the best of my knowledge, has not been exposed to any contagious or infectious diseases for 1 month prior to boarding.

\_\_\_\_\_ No horse shall receive individual turnout (when a pasture mate[s] is available) or full-time stall keeping unless ordered by a vet during an illness or injury. If horse is unable get along well with herd-mates horse will be stalled until owner finds new boarding arrangements. Owner agrees to pay an additional charge of \$25 per week that horse is stall-kept to cover additional bedding and labor costs.

\_\_\_\_\_ **In case of emergency** stable management will contact owners first and horse's veterinarian second. If stable management is unable to reach either party I consent to treatment by stable management or alternate veterinarian.

\_\_\_\_\_ Every precaution is taken to protect the horse from injury, illness, accident, fire and theft. The stable owner and/or stable management shall not, while exercising reasonable care, be held responsible for accident, injury, illness, fire or theft.

\_\_\_\_\_ I agree to give no less than **30 days paid notice** prior to leaving Whistle Stop Stables and will not receive a refund for any unused portion of pre-paid board.

\_\_\_\_\_ I understand that the worming program requires all horses to be given daily feed-thru wormer and paste-wormed twice yearly during spring and fall shots. I agree to provide my own daily wormer of any brand of my choosing.

\_\_\_\_\_ I agree to follow the rules and policies at all times and to be responsible for guests and their behavior. No guest may ride my horse without having first signed a Release of Liability.

### MONTHLY BOARD & LATE FEES

Monthly board is **\$610.00** which is due and payable on the **1<sup>st</sup>** day of each month.

Base Board Includes:     Stall         Turnout         up to 1 scoop/3 quarts Grain twice daily  
                                  Timothy or Orchard/Alfalfa Hay     Psyllium Sand Purge

If additional grain is needed for a hard-keeper it will be billed to the owner as an additional item on the board bill and at the actual cost of the grain supplied based on cost per bag at the time. Additional hay is not available for pasture boarded horses as it's impossible to provide one with more while not giving it to the others.

Board is considered **LATE on the 6<sup>th</sup>** day and will incur a **\$25.00 late fee**.

Board that is not paid in full by the **20<sup>th</sup>** day of the month, to include the \$25.00 late fee, will incur additional late fees of **\$5.00 per day**.
